11/357 Highways and Transport	The PTR recently attended the 94/95 bus service review meeting. It is anticipated that this service, with a few enhancements, will continue to go through North Moreton. Requests for the 130 to be diverted via the village have so far been unsuccessful but OCC are very aware of our wishes. The Tesco bus no longer serves North Moreton. The PTR advised that OCC will consider the desirability of a 20mph speed limit through the village at their next review (possibly not for a couple of years).	
11/358 Recreation and Playground matters	<ol style="list-style-type: none"> 1. Unfortunately it was reported that the recently planted young saplings have been stolen. 2. Also it was reported that there had been a case of wanton vandalism on the rec ground which resulted in two chestnut trees being stripped of their bark. Both incidents were reported to the police. 3. RoSPA confirmed to the clerk in writing that the inspection will take place in July. 4. Contact the Woodland Trust for advice on dealing with the trees loss of bark. 5. Rob Nickless will be installing the new fencing on the rec ground this week 6. Investigate the possibility of rotating the football pitch 90 degrees before installing the new football goalposts supports. It was proposed CIS, seconded SH and carried that up to £250 could be spent on the football goalpost supports. <p>Mick Hart has offered to obtain the use of a topper to level the rec ground just for the cost of the diesel used.</p>	RPT BH
